## CARIBBEAN WORKSHOPS

Successful workshops were held in four CNF member countries in the Caribbean: Grenada 21-22 October; Barbados 23-24 October; St Lucia 30-31 October; and Trinidad and Tobago 4-5 November. One hundred and fifty nurses attended the workshops.

The workshops titled: **4Safety**, covered: a safe patient, a safe workplace, a safe profession and a safe nurse and were facilitated by Jill Iliffe CNF Executive Secretary in collaboration with the national nurses associations in Grenada, Barbados, St Lucia and Trinidad and Tobago. Marion Howard, CNF Board member for the Atlantic Region attended and presented at all workshops. The workshops were funded by the Commonwealth Foundation.

Workshop participants committed to becoming a catalyst for change in their workplaces and to share knowledge gained with colleagues. Each of the four workshops recommended that managers be provided with leadership training to enable them to lead the change process to create a culture of patient safety.

The workshops also recommended the establishment of a process for updating and reviewing standards, policies and protocols and developing new ones where needed. The national nursing associations were congratulated by participants for the initiative in conducting the workshops in collaboration with the CNF.
