#### Commonwealth Foundation appoints new Director-General



Dr Anne Therese Gallagher has been appointed the new Director-General of the Commonwealth Foundation. Dr Gallagher is a lawyer, teacher and scholar with extensive experience in international affairs including human rights and the administration of criminal justice.

Dr Gallagher taught law at the Australian National University, and served for 12 years at the United Nations including as special adviser to the UN High Commissioner for Human Rights. From 2003, Dr Gallagher worked with the Association of South East Asian Nations to strengthen legislative and criminal justice responses to human trafficking and related exploitation.

The CNMF congratulates Dr Gallagher on her appointment and looks forward to working with and learning from her. The CNMF has enjoyed a strong and positive working relationship with the Commonwealth Foundation over many years and is confident this will continue under Dr Gallagher's leadership.

#### SUCCESSFUL WACN CONFERENCE Sierra Leone

The West African College of Nursing (WACN) held its 15<sup>th</sup> Biennial General Meeting, 24<sup>th</sup> Scientific Session, and 38<sup>th</sup> Council meeting in Freetown Sierra Leone 18-20 March 2019. The Sierra Leone Chapter of WACN hosted the conference.

The CNMF President, Professor Kathleen McCourt attended the conference together with 300 West African nurses and midwives. The theme for the conference was Health service partnerships: the role of nurses and midwives in building global health security. The President of Sierra Leone, the Hon Julius Maada Bio officially opened the conference. The international conference program provided an opportunity for nurses, midwives, other health care professionals, and the general public to come together to discuss community and health workforce responses to current health issues.

The West African College of Nursing was officially inaugurated on 14 April 1981. Countries currently comprising membership are Nigeria, Liberia, Sierra Leone, Ghana, Benin and The Gambia.

#### CNMF OPPOSES NEW PENAL CODE FOR BRUNEI DARUSSALAM

A new penal code for Brunei Darussalam came into force earlier this month. The code is reported to have extended the crimes which attract the death penalty; and introduced death by stoning as a punishment, as well as public flogging and amputation. The death penalty is already legal in Brunei Darussalam however the last execution was in 1957.

The United Nations High Commissioner for Human Rights, Michelle Bachelet warned that the new laws could encourage violence and discrimination on the basis of gender, sexual orientation, and religious affiliation. "Any religion-based legislation must not violate human rights, including the rights of those belonging to the majority religion, as well as of religious minorities and non-believers", she said.

The CNMF strongly opposes any legislation or actions which are cruel, inhuman or degrading; or which are discriminatory in nature, or breach international human rights conventions. Capital punishment is not acceptable at any time or in any form in any country, particularly any Commonwealth country. The CNMF supports other international calls for the Brunei Darussalam law to be set aside.
