COMMONWEALTH HEALTH MINISTERS

Susie Kong and Jill Iliffe, on behalf of the CNF, attended the Commonwealth Health Ministers (CHMM) meeting in Geneva on Saturday 18 May. The theme for the 2008 CHMM was *eHealth*. Jill made a presentation to the Health Ministers on behalf of the Commonwealth health professional associations (nursing, medicine, dental and pharmacy). A copy of the presentation will be available on the new CNF website. The CNF is also represented on the Commonwealth Advisory Committee for Health. The theme for the 2009 CHMM is: *Climate change and health*.

ICN MEETINGS

The CNF was also represented at the ICN meetings of national nursing associations held in Geneva 14-18 May prior to the CHMM and the World Health Assembly. It was great to see so many Commonwealth countries, who are also members of ICN, represented.

One of the most important presentations was on task shifting by the World Health Organization (WHO). The WHO response to the world wide shortage of health professionals, especially nurses and midwives, is to shift some of the current responsibilities of health professionals to other worker classifications. This is often workers who have a lower level of education and who are less expensive to educate and employ.

Strong concerns were expressed by delegates at the meeting about the lack of consultation with health professionals; the absence of a supporting framework for the workers; the potential for patients and the workers to be put at risk; and the erosion of the role of nurses and midwives. CNF FUTURE WORK

The CNF will be conducting a workshop at the SPNF in Fiji 6-10 October on safe care and safe practice. There are also four workshops on the same theme being held in the Caribbean 21-31 October in Grenada, Trinidad and Tobago, Barbados and St Lucia. Workshops on governance and leadership are being planned for Malaysia.

The Commonwealth Steering Committee for Nursing and Midwifery will be conducting workshops in India 16-17 February 2009 and the CNF is planning an associated activity to help raise funds for the Trained Nurses Association of India project to build a Central Institute of Nursing and Research including a care home for the elderly.

Additionally, the CNF has applied for funding to conduct some research on nurse migration based on a very successful research project conducted by the Nurses Association of Botswana.

The CNF is also preparing a funding submission to replicate a study conducted in Australia on nurses' access to and use of information technology and barriers to that access. The study will be replicated in a number of other Commonwealth countries giving nurses research based information to take to their governments to support better access to information technology including email and the internet.

Other work includes finalising the new CNF website which will be launched within the next few weeks and transferring CNF subscription histories to an electronic medium. Once these are completed they will be made available to individual countries.

It is certainly an exciting time for the CNF and I am looking forward to reporting to you on CNF activities at the Biennial in Botswana next year.
